# **President's Message:**Update on APA Colorado

The year 2012 is winding down and it has been an eventful year for APA Colorado. It has been one of change and, as is typical of change, the year has been accompanied by challenges and opportunities. Changes in staff created a need for greater Board involvement. The result has been a



fully engaged and knowledgeable Board, who, assisted by a newly-hired Chapter Administrator, Shelia Booth, is ready to conquer greater goals and fulfill the directives of the recently-approved Strategic Plan. Overall, each goal and resulting implementation strategy included in the Plan support the importance of planning and the need for planners.

The Strategic Plan emphasizes the theme "Partners in Planning – Finding Common Ground", and includes a variety of strategies to support the theme including partnering with allied groups; providing jointly-sponsored events with allied groups; forming coalitions with groups who have like-minded legislative goals; maintain a supportive relationship with institutions of higher learning and with student APA; and others. In addition to long-held relationships with ULI, CML, CCI, ASLA, and more, we continue our partnership with Downtown Colorado, Inc. (DCI) and on December 12<sup>th</sup>, we will collaborate to present "The Planners Bottom Line: Including Planners in Stage One." In April 2013 (exact date to be determined), we will team for the second time with transportation-focused groups WTS, ITE, and ACEC to present the 10<sup>th</sup> Annual Transportation Symposium. Additionally, we remain open to future opportunities to join forces with those with common goals.

Another Strategic Plan goal is to enhance service to members. This includes a renewed commitment to communication. Led by the V.P. of Communications, T.J. Dlubac, efforts include an emphasis on a robust quarterly newsletter; social media; and a reorganized and reactivated Communications Committee who will evaluate various communication strategies. Also targeted to augment member services is a concerted effort to provide regional events. While some regions have benefitted from regional training events, others have not seen offerings often enough. Regional Representatives will be focused on seeking these opportunities.

Also included in the Plan is the goal to enhance the Awards Program. Indeed, Awards are the centerpiece of this newsletter and we certainly have newsworthy award winners this year. At this year's Awards Celebration, which was held at the Annual Conference in Snowmass, each was roundly celebrated by a warm crowd. Each year, our Awards recipients represent the best in planning and they are all deserving of the honor and of our congratulations. 
Please join me in thanking and honoring them for all of their hard work. We know that each will continue their involvement in APA Colorado.


#### Poncha Springs Parks and Recreation Master Plan

## **APA Sustainability Committee at the 2012 Conference**

This year, the APA Colorado Sustainability Committee featured a session titled "Reduce, Reuse, and then Recycle...Transitioning to Zero Waste", in partnership with Telluride-based non-profit EcoAction Partners. While recycling has been commonplace in many Colorado cities for decades, it is far less common to find a community providing compost pick-up, restricting single-use grocery bags, or analyzing the product life-cycle of construction materials. Referred to as Zero Waste Planning, some Colorado towns are moving beyond recycling to address all types of waste generated in their communities. This is exactly what Eco-Action Partners director Kris Holstrom and her partners in the Town of Telluride, Town of Mountain Village, and San Miguel County have been working on for the past five years. Beginning with efforts to produce zero waste at the town's numerous summer festivals, the efforts in the Telluride area have expanded to examine how an entire community or region might be able produce zero (or close to zero) waste.

The session provided an overview of zero waste efforts, challenges and success stories and then provided important suggestions on how planners and community leaders can help with zero waste planning efforts. 
#### **APA Sustainability Committee Fundraising**


# **Sustainability Awards**


# **Outstanding Planning Projects**

#### Town of Ridgeway 2011 Land Use Plan Update


The Town of Ridgway and SE Group are awarded the Merit Award for their 2011 Land Use Plan Update. With a \$10,000 budget, this project truly gets the most bang for the buck! How did they do it? They focused on what was important, utilized interns, and allowed the town to look inward at the resources and expertise found within the community. These Citizen-led focus groups included local experts on the topics of artchitecture, planning and land use, education, and more to craft policies that the town and SE group could further fine tune. It is a highly user-friendly plan with a guidebook approach, making it easy to articulate the town's vision for future land use decisions. We congratulate Ridgway and SE group for their incredible cost-saving mechanisms and production of a most excellent land use plan!




# MERIT AWARD The Economic Power of Heritage and Place

Clarion Associates, through the Colorado Historical Foundation and History Colorado, prepared a unique, multi-year, comprehensive study of the economic and other benefits of historic preservation throughout Colorado. This plan captures the economic benefits of preservation at two levels – the statewide level, by looking at cumulative impacts of the rehabilitation of historic buildings, heritage tourism, and programs like the Colorado Main Street program. At a more focused level, the report documents the economic importance of preservation for the owners and users of historic properties, look-

ing at issues like property value trends. The result is a valuable advocacy tool for


#### President's Award







Meetings for this project included child-care, pizza, and using display boards with pictures, and not words. This was a successful way to engage the community and show the city what was truly important to the neighborhood. Congratulations to LiveWell Westwood and The City and County of Denver!

#### Zumba in Westwood - Sharing Facility Space to Overcome Resource Scarcity

We are a healthy state here in Colorado. Look out your window anywhere you go, and you'll likely see somebody exercising – be it a professional cyclist on a bike, or a family walking one of our amazing trail systems. Meanwhile, the US is suffering from an epidemic. Even in Colorado, the number of children and adults with obesity is continually on the rise. Planners have a direct role in shaping our built environment.

This category recognizes successfully implemented programs and projects which work to overcome the obesity epidemic in our communities. The successful recipient of this category will have made changes to the built environment and community lifestyles which lead to the



increased access to healthy foods, exercises or social wellness within their communities.

This years recipient has shown depth in community engagement, high rates of community participation, agency collaboration, innovative ideas and achievement of project goals.

This year, we recognize one particular program that shaped bodies in the Westwood neighborhood in west Denver. LiveWell Colorado partnered with the Westwood neighborhood to pay for 6 women and 1 man to be trained Zumba instructors. In addition, they organized coalition partners with gyms to request that they allow Zumba to occur in their facilities. This program solved problems of this neighborhood of no one to exercise with, and nowhere to exercise. This program offers zumba instruction to participants at a requested donation of 1-2\$.
